Dr. Rizal Sukma (Chapter 1) is Executive Director at the Centre for Strategic and International Studies (CSIS), Jakarta. Dr. Andrew S. Erickson (Chapter 7) is an Associate Professor in the Strategic Research Department at the U.S. Naval War College and a founding member of the department’s China Maritime Studies Institute (CMSI). He is a Fellow in the Princeton-Harvard China and the World Program, an Associate in Research at Harvard University’s Fairbank Center for Chinese Studies, and a Fellow in the National Committee on U.S.-China Relations’ Public Intellectuals Program. Erickson previously worked for Science Applications International Corporation (SAIC) as a Chinese translator and technical analyst. Studies, The American Interest, and Joint Force Quarterly.
